**Kentucky Power Company's Motion To Suspend
September 16, 2013 Procedural Schedule**

Kentucky Power Company moves the Public Service Commission of Kentucky to suspend the September 16, 2013 procedural schedule in this proceeding until the later of the expiration of the period for seeking rehearing in Case No. 2012-00578, or the conclusion of rehearing proceedings, if any, in Case No. 2012-00578. In support of its motion Kentucky Power states:

1. On October 7, 2013 the Commission entered its Order approving with modifications the Stipulation and Settlement Agreement among Kentucky Power Company, Sierra Club, and Kentucky Industrial Utility Customers, Inc. in Case No. 2012-00578. The Attorney General was not a party to the Stipulation and Settlement Agreement and retains full rights to seek rehearing of or otherwise challenge the Commission's October 7, 2013 Order.
2. The period to seek rehearing in Case No. 2012-00578 expires October 30, 2013.
3. On October 14, 2013 Kentucky Power filed its acceptance of, and agreed to be bound by, the modifications to the Stipulation and Settlement Agreement set in forth in Appendix B to the Commission's October 7, 2013 Order.

4. If rehearing is sought and granted the Commission could modify the terms of its October 7, 2013 Order in Case No. 2012-00578, including its approval of the Stipulation of Settlement Agreement.

5. Under paragraph 3 of the Stipulation and Settlement Agreement the Company agreed to withdraw its application in this case following the Commission's approval of the Stipulation and Settlement Agreement in Case No. 2012-00578.

6. The September 16, 2013 procedural schedule in this proceeding requires that "all supplemental requests for information" be filed on or before October 25, 2013.

7. Suspension of the procedural schedule in this case until the later of the expiration of the period for rehearing or the conclusion of rehearing proceedings, if any, in Case No. 2012-00578 will eliminate the need for further effort in this case that is likely to prove unnecessary.


8. This motion is not made for purposes of delay. The requested suspension of this proceeding will further the efficiency of this proceeding and will not prejudice any parties to the proceeding.

WHEREFORE, Kentucky Power Company respectfully requests the Commission to enter an Order:

1. Suspending the procedural schedule in this case until the later of the expiration of the period for seeking rehearing in Case No. 2012-00578, or the conclusion of rehearing proceedings, if any, in Case No. 2012-00578; and

2. Granting Kentucky Power all further relief to which it may be entitled.
