ORDER

The Commission is in receipt of the motion of Big Rivers Electric Corporation ("Big Rivers") requesting that we schedule the evidentiary hearing in this case for some time in the first week of December 2013. In support of its motion, Big Rivers takes notice that the last event in the existing procedural schedule is its filing of rebuttal testimony on November 20, 2013. Big Rivers states that one of its witnesses, Daniel Walker, will be out of the country and unavailable from December 8, 2013, to December 22, 2013. Big Rivers requests that the hearing be scheduled in the period of December 2 through December 6, 2013, to accommodate Mr. Walker's attendance.

While we are unable to grant Big Rivers' request that the hearing be scheduled in the first week of December 2013, the Commission will accommodate Big Rivers' request by scheduling the evidentiary hearing to commence on January 7, 2014.

IT IS THEREFORE ORDERED that:

1. Big Rivers' motion is granted to the extent that an evidentiary hearing shall be scheduled to commence on Tuesday, January 7, 2014, at 10:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

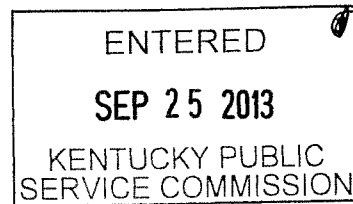
2. Big Rivers shall publish notice of this hearing in compliance with 807 KAR 5:001, Section 9(2)(b). At the time publication is requested, Big Rivers shall forward a duplicate of the notice and request to the Commission.

3. Big Rivers shall file with the Commission no later than January 6, 2014, proof of publication of its notice of the hearing in each of the publications in which it published notice.

4. The official record of these proceedings shall be by video only.

5. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
