

Application of Big Rivers Electric Corporation for a General Adjustment in Rates Supported by a Fully Forecasted Test Period

Pursuant to a Commission Staff notice dated October 4, 2013, a telephonic informal conference was held on October 3, 2013. A list of the attendees is attached hereto.

The purpose of the conference was to discuss the request of the Attorney General, Kentucky Industrial Utility Customers, Inc., and Sierra Club to revise the procedural schedule in light of the hearing being scheduled to begin on January 7, 2014. After several minutes of discussion, the parties were able to reach an agreement to revise the outstanding deadlines contained in the current procedural schedule. Specifically, the proposed changes are as follows:

- Intervenor testimony should be changed from October 14, 2013 to electronic service by the intervenors of their testimony by October 28, 2013, with hard copies to be filed by October 29, 2013;
- Data requests to intervenors should be changed from October 25, 2013 to electronic service of the data requests by November 11, 2013, with hard copies to be filed by November 12, 2013;
- Intervenors' responses to data requests should be changed from November 7, 2013 to November 22, 2013; and
- Big Rivers Electric Corporation's rebuttal testimony changed from November 20, 2013 to December 17, 2013.

Commission Staff indicated that it had no objections to these revisions and that an order revising the existing procedural schedule should be issued within a week.

There being no further discussions, the informal conference was adjourned.
