**MOTION TO INTERVENE OF
CENTURY ALUMINUM OF KENTUCKY GENERAL PARTNERSHIP**

Pursuant to 807 KAR 5:001 Section 4(11), Century Aluminum of Kentucky General Partnership ("Century" or the "Company") requests that it be granted full party status in the above-captioned proceeding. In support thereof, Century states the following:

1. Century owns and operates an aluminum reduction plant located in Hawesville, Kentucky ("Hawesville Smelter"), and purchases electric energy and related services from Kenergy Corp. pursuant to a Retail Electric Service Agreement dated July 1, 2009. The address for the Hawesville Smelter is 1627 State Route 3543, Hawesville, KY 42348.

2. The Hawesville Smelter consumes substantial quantities of electricity in its processes, making Century one of Kentucky's largest electricity consumers. The matters being decided by the Kentucky Public Service Commission ("Commission") in this proceeding will have a significant impact on the rates paid by Century for electricity. Therefore, Century has a special interest in this proceeding that cannot be adequately represented by any other party.

3. Century hereby moves for leave to intervene and to be heard on all issues before the Commission. Granting full intervention to Century will allow Century to present issues or develop facts that will assist the Commission in fully considering this matter without unduly complicating or disrupting this proceeding.
