MOTION TO INTERVENE OF MEADE COUNTY RECC

Comes Meade County RECC ("Meade"), by counsel, and moves the Commission for entry of order allowing it full intervention in this proceeding pursuant to 807 KAR 5:001 §3(8). In support of this motion, Meade states:

1. Meade is a rural electric cooperative corporation organized pursuant to KRS Chapter 279. Meade's mailing address is Post Office Box P.O. Box 489, Brandenburg, Kentucky 40108. Meade is a retail electric supplier as defined under KRS 278.010(4) and is one of the three (3) member-owners of Big Rivers Electric Corporation ("Big Rivers").

2. Meade is a member-owner of Big Rivers and a distributor of energy produced by Big Rivers has an interest in ensuring that the allocation of the costs of environmental compliance plan are allocated fairly among the different classes of rate payers. Granting full intervention to Meade will not unduly complicate or disrupt this proceeding.
