ORDER

This matter arises upon the motion of Hickman County Fiscal Court for intervention.<sup>1</sup> Having been otherwise sufficiently advised, the Commission finds that Hickman County Fiscal Court is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings and that Hickman County Fiscal Court should be granted full rights of a party in this proceeding.

IT IS HEREBY ORDERED that:

1. The motion of Hickman County Fiscal Court to intervene is granted.
2. Hickman County Fiscal Court shall be entitled to the full rights of a party and, pursuant to 807 KAR 5:001, Section 8, shall be served with electronic notice of the issuance of all Commission Orders issued after the date of this Order and of all documents filed by any party to this proceeding.
3. Within seven days of the date of this Order, Hickman County Fiscal Court shall file with the Commission a written statement that it waives any right to service of

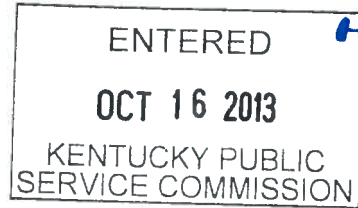

Commission orders by United States mail and that it or its authorized agent possesses the facilities to receive electronic transmissions.

4. Hickman County Fiscal Court shall comply with all provisions of 807 KAR 5:001, Section 8, related to the electronic filing of documents.
