**REQUEST 1**

**RESPONSIBLE PARTY: Craig A. Johnson**

**Request 1.** Refer to Commission Staff's Information Request 7, at page 7 of 45, and provide information concerning the three outages for Spurlock Unit 3 (Gilbert) that resulted from "Loss of Bed Material", stating what Loss of Bed Material means and how it occurs.

**Response 1.** The "Loss of Bed" trips of 11/5/12, 12/12/12 & 4/21/13 were a result of ash inadvertently plugging and accumulating in one of the separation cyclones. When this occurs the bed is obstructed from returning to the primary furnace reducing the needed bed material required for proper operation. Once the bed is reduced to a level that will not support heat transfer, the unit trips on low bed differential pressure.

**Request 2.** Refer to Commission Staff's Information Request 15 a-c. Please provide a version of EKPC Board Policy No. 404, Transaction Authority Limits for Energy and Energy Related Commodities and Transportation, which tracks all changes made from the previous version of the Policy to the current version of the Policy, and include a brief explanation of the reasons for all such material changes.

**Response 2.** Each of the changes in the document (Policy 404) as it relates to power and transmission were related to products needed to operate in PJM (capacity, demand bid, FTR, ARR, virtual, ancillary services, generation award). A redacted copy of a "track changes" version of this policy is provided on pages 2 through 18 of this response and includes brief explanations of the reasons for all such material changes.
