BE IT ORDAINED BY THE CITY I MCLEAN COUNTY, KENTUCKY, AS FOLL

That there be, and is hereby, levied a the year 2013 upon the following named PERSONAL PROPERTY AND FRANCHISE expenses of said City, viz:

On each \$100.00 worth of taxable real franchises, owned or kept within the city ll levied a tax of .191 cents.

On each \$100.00 worth of taxable including franchises, owned or kept withir is hereby levied a tax of .2498 cents.

The property taxes and tax on franchises said city shall be due and payable within date the tax bills are mailed. Bills that are days of the date the tax bills are mailed discount of two percent (2%) of the face ar become delinquent on the sixtieth day (the following the date the tax bills are mailed to a penalty of five percent (5%) on the t: paid within thirty (30) days of said delinq due and unpaid within ninety (90) days a bills are mailed shall be subject to a pe (10%), and, in addition, the taxes so due the rate of twelve percent (12%) per annum paid. Partial payments will be accepted, interest will only apply to unpaid balance lien is placed on any property for delinque not to exceed the amount of the filing fee total tax bill to cover the cost of such filing. that any amount collected on an account for prior years' taxes to be applied to the first, and only after any delinquency is sa to the current year's tax bill.
