MOTION OF KENTUCKY UTILITIES COMPANY  
TO MODIFY PROCEDURAL SCHEDULE

Kentucky Utilities Company ("KU") hereby moves the Kentucky Public Service Commission ("Commission") to reschedule the public hearing currently scheduled for March 13, 2014, to any time convenient to the Commission during the week of Monday, March 24, 2014. The witness KU plans to present at the hearing, Robert M. Conroy, Director of Rates, will not be available on March 13. KU's counsel contacted the Complainant, Jeff M. Short, about the need to move the hearing, and Mr. Short authorized counsel to represent that he does not object.

KU further moves the Commission to permit Mr. Short and KU to file pre-hearing written comments in the record of this proceeding no later than Friday, March 7, 2014. KU believes such comments may help clarify the issues in the proceeding before the public hearing. Mr. Short has authorized counsel to represent that he does not object to this request.

KU respectfully asks the Commission to issue the requested order by February 21 to permit the parties adequate time to prepare for hearing and to draft comments if the Commission permits them.

KU further respectfully asks the Commission to issue the requested order by February 21.
