

NOTICE

Joann Estates Utilities, Inc. has filed an application with the Public Service Commission proposing to increase its monthly sewer rate from \$19.66 to \$35.00, an increase of 78%. Joann Estates believes it could justify an even greater increase, but is proposing the increase to \$35 to reduce the burden upon its customers. In addition, Joann Estates believes the proposed \$35 rate would still be lower than the average rate charged by similar sewer utilities in Kentucky. The proposed increase is necessary to provide adequate sewer service and to fully comply with existing and new environmental requirements. The proposed effective date of the change is September 16, 2013.
