RE: Proposed boundary line between Jackson Purchase Energy Corporation (JPEC) and West Kentucky Rural Electric Cooperative Corporation (WKRECC)

Dear Mr. Derouen:

Enclosed please find Hickory, West Plains, Blandville, Melber, Fancy Farm, Lovelaceville, Calvert City, Briensburg, Elva and Symsonia USGS quadrangle maps that reflect the boundary lines as they presently exist and proposed/revised boundary lines between Jackson Purchase Energy Corporation (JPEC) and West Kentucky Rural Electric Cooperative Corporation (WKRECC). Both parties have strived to eliminate the splitting of property parcels. Only in cases where a potential duplication of facilities would be required, have the parties agreed to divide a property parcel.

Also included is the Wickliffe USGS quadrangle map, which includes JPEC, WKRECC and Kentucky Utilities Company (KU) boundary lines; therefore all parties are signatories to this map. The Wickliffe map also includes within the signature block the appropriate language as suggested by Kentucky Utilities, *“Kentucky Utilities Company acknowledges that its certified territory boundary as shown is consistent with boundary as established in 1972 and reconfirmed in 1982, and that no changes to this boundary are being made in connection with this filing.”*

The applicable Property Valuation Administrator’s office provided the property parcel data, when the data was available. Both parties have worked on the revised boundary line as shown and agree the proposed boundary line is in the best interest of our respective member/owners. No existing members are being moved to a different supplier; all existing members remain with their current supplier, other than the one member stipulated below. The proposed boundary lines also corrects those members who, for whatever reason are being served by the utility outside its previously certified boundary maps.

A previously existing member of WKRECC is now being served by JPEC under the terms of a separate agreement. These maps are also submitted to verify the results of the agreement between Goodman & Sons Lumber, WKRECC and JPEC, as shown within the Symsonia quadrangle map.

The parties, WKRECC and JPEC, with the concurrence of KU, where applicable, hereby request the approval of the Commission of the revised boundary maps as submitted. The revised approved maps would be the official maps between JPEC, WKRECC and KU (where applicable).



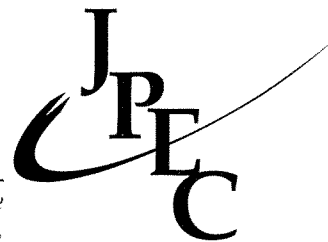
