Dear Mr. Derouen:

This letter is to advise the Commission that Kentucky Industrial Utility Customers, Inc. will not be filing testimony in the above-captioned proceeding in light of the following language on pages 3-4 of the Commission's December 30, 2013 Order in this proceeding:

*"... the Commission finds that the use of the RER funds for Big Rivers' Industrial and Rural customers, rather than only for its Rural customers, is an issue raised by KIUC in Case No. 2013-00199 and should be determined in that case. It is Big Rivers, not Kenergy, that holds those funds and that has made the proposal for the accelerated use of those funds. Moreover, the issue of the appropriateness of a flow-through proceeding is not ripe, because a final determination has not been made in Case No. 2013-00199 concerning how the RER funds are to be applied."*


