ORDER

On November 5, 2013, in Case No. 2013-00150,<sup>1</sup> the Commission approved rates for Valley Gas, Inc. ("Valley Gas") and provided for their further adjustment on a quarterly basis in accordance with Valley Gas's Gas Cost Recovery ("GCR") clause.

On November 18, 2013, Valley Gas filed its GCR to be effective January 1, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Valley Gas's notice includes a revised rate designed to pass on to its customers its expected change in wholesale gas costs.
2. Valley Gas's proposed Expected Gas Cost ("EGC") is \$4.9778 per Mcf, which is a decrease of \$.0481 per Mcf from the previous EGC of \$5.0259 per Mcf.
3. Valley Gas's notice sets out no current quarter Refund Adjustment.
4. Valley Gas's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0186) per Mcf. Valley Gas's total AA is (\$.0824) per Mcf, which is a decrease of \$.0492 per Mcf from the previous total AA of (\$.0332) per Mcf.
5. Valley Gas's notice sets out a GCR of \$4.8954 per Mcf, which is a decrease of \$.0973 per Mcf from the previous GCR of \$4.9927 per Mcf.

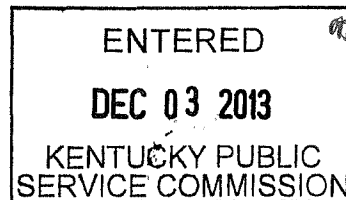
6. The rate in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Valley Gas on and after January 1, 2014.

IT IS THEREFORE ORDERED that:


1. The rate in the Appendix attached hereto and incorporated herein is approved for service rendered on and after January 1, 2014.
