13 MOTION FOR INCORPORATION BY REFERENCE

15 Kenergy Corp. (“Kenergy”) and Big Rivers Electric Corporation (“Big  
16 Rivers”) jointly move pursuant to 807 KAR 5:001 §11(5) that the Kentucky  
17 Public Service Commission (the “Commission”) make an order incorporating  
18 the record from Case No. 2013-00221<sup>1</sup> (the “*Century Hawesville Case*”) into  
19 the record of this proceeding by reference only. In support of their motion,  
20 Kenergy and Big Rivers state, through counsel:

21 1. The Century Hawesville Case involved the same applicants, a  
22 commonly-owned retail customer, contractual arrangements that are nearly  
23 identical substantively and likely the same intervenors that will be involved  
24 in this proceeding.


25 2. The discovery and testimony in the Century Hawesville Case


