Pursuant to K.R.S. §278.310 and 807 KAR 5:001 Section 3(8), Century Aluminum Sebree LLC (“Century”) requests that it be granted full intervenor status in the above captioned proceeding and states in support thereof as follows:

1. Century owns and operates an aluminum reduction facility in Sebree, Kentucky, and purchases from Kenergy Corp. electric energy generated by Big Rivers Electric Corporation (“Big Rivers”) under a Retail Electric Service Agreement dated July 16, 2009.

2. Electric service represents a significant cost of doing business for Century. The matters being addressed and decided by the Commission in this proceeding will have a significant impact on the rates paid by Century for electricity. Therefore, Century has a special interest in this proceeding that cannot be adequately represented by any other entity. Century intends to play a constructive role in the Commission’s decision making process herein and its participation will not unduly prejudice any party.


