Motion To Amend Procedural Schedule

Kentucky Power Company moves the Public Service Commission of Kentucky to amend the January 13, 2014 Order establishing a procedural schedule in this case to permit Kentucky Power to file comments in response to the comments to be filed by Sierra Club.


The current procedural schedule does not provide an opportunity for Kentucky Power to file written responses to the testimony (now comments) to be filed by Sierra Club on or before March 28, 2014. Kentucky Power requests that the existing procedural schedule be amended to permit Kentucky Power to file written comments in response to Sierra Club's comments on or before May 9, 2014. May 9, 2014 is two weeks after the date for Sierra Club to file its responses to Kentucky Power's data requests.

Although Kentucky Power anticipates that the matter could then be submitted to the Commission on the record and without hearing, it would like to reserve the right to request a hearing in the event it determines a hearing would be useful. Thus, Kentucky Power suggests that the date for requesting a hearing be changed from May 5, 2014 to May 9, 2014 so as to coincide with the filing of its comments.
