ORDER

On January 9, 2014, the Commission accepted for filing the joint application of W & W Service Co.¹ ("W & W") and the Paducah-McCracken County Joint Sewer Agency ("JSA") to transfer control of the Terre Verte Subdivision sewage treatment and collection system to JSA. The Commission issued an Order on March 6, 2014, approving the transfer of control of the Terre Verte Subdivision sewage treatment and collection system subject to four conditions identified in the Order. Upon issuance of the March 6, 2014 Order, the Commission closed the case file.

The parties have now filed a motion for an extension of time to comply with one of the conditions set forth in the March 6, 2014 Order. Ordering paragraph 3 of the March 6, 2014 Order states:

If W & W and JSA fail to execute and implement the proposed transfer of control by June 30, 2014, this Order shall be deemed void and without legal effect.

The parties state that JSA needs more time for completion of the construction to extend its lines to connect to the Terre Verte Subdivision's wastewater collection system. The parties request that they have until September 30, 2014, to complete the transfer of control.

Having reviewed the March 6, 2014 Order and the parties' motion, and being otherwise advised, the Commission finds that:

1. This case file should be reopened for the limited purposes discussed in this order.

2. W & W and JSA should have until September 30, 2014, to execute and implement the proposed transfer of control.

3. The parties should be given additional time to comply with Ordering paragraph 5 of the March 6, 2014 Order which states:

Within 120 days of the date of this Order, W & W shall file with the Commission a financial and statistical report for its operations for the period from January 1, 2014, until the date of transfer of ownership.

IT IS THEREFORE ORDERED that:

1. This case file is reopened for the limited purposes specified in this Order.

2. Ordering paragraph 3 of the March 6, 2014 Order is modified to the limited extent that W & W and JSA shall have until September 30, 2014, to execute and implement the transfer of control proposed in their application.

3. Ordering paragraph 5 of the March 6, 2014 Order is modified to the limited extent that W & W shall file with the Commission within 120 days of completion of the transfer, a financial and statistical report for its operations for the period from January 1, 2014, until the date of transfer of ownership.

4. All other provisions of the Commission's March 6, 2014 Order shall remain in full force and effect.
