# PURCHASED WATER ADJUSTMENT FILING OFCASE NO.BRACKEN COUNTY WATER DISTRICT2014-00037

### <u>ORDER</u>

On February 10, 2014, Bracken County Water District ("Bracken County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure<sup>1</sup>.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Bracken County purchases water from Augusta Regional Water Treatment ("Augusta").

2. On February 26, 2014, Augusta increased its wholesale water rate to Bracken County from \$1.79 per 1,000 gallons to \$1.83 per 1,000 gallons.<sup>2</sup> Bracken County proposes to increase the water rates to its customers effective February 26, 2014.

3. During the 12 months ending December 31, 2013, Bracken County purchased 164,591,000 gallons of water from Augusta and sold 138,341,700 gallons. The increase in the cost of purchased water is \$6,583.64, resulting in a purchased water adjustment of \$0.05 per 1,000 gallons.

4. The purchased water adjustment of \$0.05 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

5. Bracken County's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after February 26, 2014.


IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.05 per 1,000 gallons is approved.

2. Bracken County's proposed rates are approved for water service rendered on and after February 26, 2014.

3. Within 20 days of the date of this Order, Bracken County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
