COMMISSION STAFF'S INITIAL REQUESTS FOR INFORMATION TO RUSSELL MURPHY, JR.

Complainant Russell Murphy, Jr., pursuant to 807 KAR 5:001, is to file with the Commission the original and nine copies of the following information, with a copy to all parties of record. The information requested herein is due on or before June 23, 2014. Responses to requests for information shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. Complainant shall make timely amendment to any prior responses if he obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which Complainant fails or refuses to furnish all or part of the requested information, he shall provide a written explanation of the specific grounds for his failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request.

1. Provide copies of any and all correspondence between yourself and Inter-County Energy Cooperative Corporation ("Inter-County") regarding any outages experienced by you within the last ten years.

2. Refer to your Complaint in which you mention being without electricity for a week in 2005. Provide a more detailed narrative of the cause of the outage, when the outage occurred, the specific period of time that you were without electric service, and any communication that you had with Inter-County regarding this outage.

3. Provide a listing of all outages that you have experienced within the last ten years and how long you were without power for each outage.

4. Have you lived at your current address for the last ten years?
