ORDER

On May 1, 2015, Bullitt Utilities, Inc. ("Bullitt Utilities") filed a request to deviate from the requirement that it file one original and ten copies of its Answers to Commission Staff's Post-Hearing Data Requests ("Staff's Post-Hearing Requests"). Bullitt Utilities filed only the original of its Answers to Staff's Post-Hearing Requests. Bullitt Utilities' Answers to Staff's Post-Hearing Request, Item 2, contained large or oversized maps. In support of its motion, Bullitt Utilities states that if the "documents were submitted as exhibits during the hearing . . . only one copy would have been required to be filed."

Having considered the motion, the Commission finds that:

1. When a document is presented for inclusion in the record during a hearing, only one copy is required to be filed as an exhibit to the video transcript, but the party presenting the document is expected to provide copies to all other parties, Commission Staff, and each Commissioner.
2. Pursuant to 807 KAR 5:001, Section 7(1), the Commission may order a party to file fewer than ten copies of documents filed with the Commission.
3. Bullitt Utilities' request to deviate from the requirement to file one original and ten copies of its Answers to Staff's Post-Hearing Requests should be denied to the

extent that Bullitt Utilities has not filed any copies of its Answers to Staff's Post-Hearing Requests.

4. Bullitt Utilities should not be required to file any copies of the large or oversized maps provided in its Answer to Staff's Post-Hearing Request, Item 2.

5. Bullitt Utilities should file two copies of its Answers to Staff's Post-Hearing Requests, except for the large or oversized maps provided in its Answer to Item 2.


IT IS THEREFORE ORDERED that:

1. Except for the large or oversized maps provided in its Answer to Staff's Post-Hearing Request, Item 2, Bullitt Utilities' request to deviate from the requirement that it file one original and ten copies of its Answers to the Staff's Post-Hearing Requests is denied to the extent that Bullitt Utilities has not filed any copies of its Answer to Staff's Post-Hearing Requests.

2. Bullitt Utilities is not required to file any copies of the large or oversized maps provided in its Answer to Staff's Post-Hearing Request, Item 2.

3. Within ten days of entry of this Order, Bullitt Utilities shall file two copies of its Answers to Staff's Post-Hearing Requests exclusive of the large or oversized maps provided in its Answer to Item 2.
