ORDER

On June 30, 2014, Airview Utilities, LLC ("Airview") tendered its application for an adjustment of its rates for service pursuant to the procedures set forth in 807 KAR 5:076. After Airview corrected a deficiency, its application was deemed filed on August 28, 2014. Finding that a procedural schedule should be established to ensure the orderly review of Airview's application, the Commission HEREBY ORDERS¹ that:

1. Airview shall file with the Commission, no later than September 30, 2014, the original and ten copies of the information requested in the Appendix, with a copy to all parties of record.

a. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

b. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or

¹ No action is necessary to suspend the effective date of Airview's proposed rates for general water service. Pursuant to 807 KAR 5:076, Section 7(1), an applicant who applies for a rate adjustment pursuant to the procedures set forth in 807 KAR 5:076 may not place its proposed rates into effect until the Commission approves those rates or six months from the date of the filing of its application.

person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

c. Any party shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect.

d. For any requests to which a party fails or refuses to furnish all or part of the requested information, that party shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

e. Careful attention should be given to copied material to ensure its legibility. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

2. No later than November 20, 2014, Commission Staff shall file with the Commission and serve upon all parties of record a written report containing its findings and recommendations regarding Airview's requested rate adjustment.

3. No later than December 9, 2014, or 19 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party of record shall file with the Commission:

a. Its written comments on and any objections to the findings and recommendations contained in the Commission Staff Report;

b. Any additional evidence for the Commission's consideration; and,

c. Written notice as to whether this matter may be submitted for decision based upon the existing record without hearing.

4. If Commission Staff finds that Airview's financial condition supports a higher rate than Airview proposes or the assessment of an additional rate or charge not proposed in Airview's application, Airview in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should authorize the assessment of the higher rate or the recommended additional rate or charge.

5. If Commission Staff recommends changes in the manner in which Airview accounts for the depreciation of Airview's assets, Airview in its response to the Commission Staff Report shall also state its position in writing on whether the Commission should require Airview to implement the proposed change for accounting purposes.

6. A party's failure to file written objections to a finding or recommendation contained in the Commission Staff Report by December 9, 2014, or 19 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed as agreement with that finding or recommendation.

7. Unless all parties request that this matter be submitted for decision upon the existing record, an informal conference shall be held in this matter on December 18, 2014, at 2:00 p.m., Eastern Standard Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

8. Unless all parties request that this matter be submitted for decision upon the existing record, a formal hearing in this matter shall be held in the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, at a date and time to be subsequently announced.

9. Each party shall file with the Commission, no later than January 5, 2015, a list of the persons it intends to call as witnesses at the scheduled hearing and a summary of each witness's expected testimony.

10. Airview shall publish notice of the scheduled hearing in accordance with 807 KAR 5:076, Section 12, no more than 21 days and no less than seven days before the day of the scheduled hearing.

11. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9)(a), the record of the formal hearing in this matter shall be by videotape.

12. Commission Staff shall prepare a written list of all exhibits presented at the hearing and shall file this list, with all hearing exhibits, and a copy of the video transcript of the hearing with the Commission.

13. Any motion to intervene shall be filed no later than September 25, 2014.

14. A person who submits a motion to intervene after September 25, 2014, and upon a showing of good cause is granted full intervention shall accept and abide by the existing procedural schedule.
