ORDER

On August 14, 2014, North Shelby Water Company; U.S. 60 Water District of Shelby and Franklin Counties, Kentucky; Elkhorn Water District; Farmdale Water District; Northeast Woodford County Water District; and Peaks Mill Water District (collectively "Intervenors") by counsel moved for a revised procedural schedule. Pursuant to the Commission's Order entered July 23, 2014, Intervenors and Commission Staff were to serve requests for information on Frankfort Electric and Water Plant Board ("Frankfort") no later than August 15, 2014.

To support their request for a revised procedural schedule, Intervenors indicate that they were not able to select and hire a rate analyst until Friday, August 8, 2014. Due to military reserve training, the rate analyst was not able to begin reviewing the documents until this week. The rate analyst did not have sufficient time to prepare requests for information and submit them by August 15, 2014.

Counsel for the Intervenors advises that the other parties in this case do not object to the revised procedural schedule.

Having considered the motion, the Commission finds that the Intervenors' motion for a revised procedural schedule should be granted.

IT IS THEREFORE ORDERED that:

- 1. Intervenors' motion for a revised procedural schedule is granted.
- 2. The procedural schedule set forth in the Appendix to this Order shall be followed.
- 3. All provisions of the July 23, 2014 Order that are not in conflict with the terms of this Order shall remain in effect.
