ORDER

Having discovered errors in the Commission's May 29, 2015 Order in this matter, the Commission, on its own motion, finds that Appendix B to that Order should be revised to the limited extent that the effective dates for GS-3 (Residential and Farm Time-of-Day Rate) are amended to May 31, 2015, for Phase 1 and January 1, 2016, for Phase 2, and further to reflect the approved non-recurring charges. It is therefore ORDERED, *nunc pro tunc*, that:
