ORDER REGARDING REQUEST FOR CONFIDENTIAL TREATMENT

On April 6, 2015, Kentucky Industrial Utility Customers, Inc. ("KIUC") tendered its responses to Kentucky Utilities Company's ("KU") Request for Information. With its filing, KIUC submitted a letter and a confidential CD containing Excel spreadsheets utilizing KU employee compensation and benefit information for which KU requested confidential protection in a petition filed on January 23, 2015. The Commission granted KU's petition for confidential protection and ordered that the materials not be placed in the public file by Order dated December 2, 2015.

As KIUC's response contains information for which confidential protection has been granted and which was filed confidentiality, the Commission will treat KIUC's letter filing the CD as a petition for confidential protection pursuant to 807 KAR 5:001, Section 13, and KRS 61.878(1).

Having carefully considered the motion and the materials at issue, the Commission finds that:

1. KIUC's April 6, 2015 filing contains information which was previously granted confidential protection and which remains entitled to confidential protection pursuant to KRS 61.878(1)(a) and 807 KAR 5:001, Section 13.

2. Pursuant to KRS 61.878, the material for which Movant requests confidential protection shall not be placed in the public record or made available for public inspection for an indefinite period of time, or until further Order of the Commission.

IT IS THEREFORE ORDERED that:

1. Movant's motion for confidential protection of its responses to the KU's Request for Information, Item 11, is granted.

2. Pursuant to KRS 61.878, the information for which Movant requests confidential protection shall not be placed in the public record or made available for public inspection for an indefinite period of time, or until further Order of the Commission.

3. Use of the materials in question in any Commission proceeding shall be in compliance with 807 KAR 5:001, Section 13(9).

4. Movant shall inform the Commission if the materials in question become publicly available or no longer qualify for confidential treatment.

5. If a non-party to this proceeding requests to inspect materials granted confidential treatment by this Order, the Movant shall have 20 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If Movant is unable to make such demonstration, the requested materials shall be made available for inspection.
