ORDER

On November 21, 2014, Elkhorn Water District ("Elkhorn") submitted an application for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Elkhorn purchases water from the Frankfort Electric & Water Plant Board ("Frankfort").
- 2. On November 12, 2014, Frankfort increased its wholesale water rate to Elkhorn from \$2.01 per 1,000 gallons to \$2.25 per 1,000 gallons.² Elkhorn proposed to increase the water rates to its customers effective November 18, 2014.
- 3. During the 12 months ended September 30, 2014, Elkhorn purchased 65,264,900 gallons of water from Frankfort and sold 54,024,500 gallons of water. The increase in the cost of purchased water is \$15,663.58, resulting in a purchased water adjustment factor of \$0.29 per 1,000 gallons.

- 4. The purchased water adjustment of \$0.29 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 5. Elkhorn's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after November 18, 2014.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$0.29 per 1,000 gallons is approved.
- Elkhorn's proposed rates are approved for service rendered on or after
 November 18, 2014.
- 3. Within 20 days of the date of this Order, Elkhorn shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
