ORDER

Western Mason County Water District ("Western Mason") has applied to adjust its water service rates. By this Order, the Commission approves a two-phase rate adjustment that will ultimately produce additional water service revenues of \$219,265, a 44.61 percent increase to pro forma present rate revenues of \$491,473.

Phase 1 rates, as shown in Appendix A, will increase the monthly bill of a typical residential customer¹ from \$39.50 to \$47.53, an increase of \$8.03, or 20.33 percent. Phase 2 rates as shown in Appendix B, will increase the monthly bill of a typical residential customer from the Phase 1 rate of \$47.53 to \$57.19, an increase of \$9.66, or 20.32 percent.

Western Mason tendered its application pursuant to 807 KAR 5:076 on December 1, 2014. The application was considered filed on December 23, 2014, when all filing deficiencies were cured. On January 12, 2015, the Commission issued a procedural order to ensure the orderly review of Western Mason's application.

During its field review, Commission Staff discovered that Western Mason had an outstanding ten-year, \$86,374 loan payable to the Bank of Maysville dated January 10,

2014. Western Mason acknowledged that it did not seek or receive approval from the Commission to enter in the evidence of indebtedness as required by KRS 278.300. Western Mason had also entered into at least three other evidences of indebtedness, none of which are still outstanding, without seeking approval from the Commission.

Staff applied methods and practices that are generally accepted by the Commission to review the reasonableness of the rates and charges requested in Western Mason's application. On March 24, 2015, Staff issued a report finding that Western Mason's adjusted test-year operations support a \$219,265 increase to annual water sales revenue. Staff also found that Western Mason should change the depreciable lives assigned to certain assets when calculating depreciation for accounting and ratemaking purposes.

On April 2, 2015, Western Mason filed its responses to Staff's report wherein it accepted Staff's findings and requested that the scheduled informal conference be cancelled. By order dated April 8, 2015, the informal conference was cancelled.

Having considered the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Western Mason was organized pursuant to KRS Chapter 74. It owns and operates a water distribution system through which it provides water service to approximately 1,032 customers in Bracken and Mason counties, Kentucky.²
- The calendar year ending December 31, 2013, should be used as the test year to determine the reasonableness of Western Mason's existing and proposed water rates.

- 3. Based upon pro forma test-year operations, Western Mason's total pro forma present rate revenue and total pro forma operating expenses, after adjusting for known and measurable charges, are \$517,251 and \$533,411, respectively.³
- 4. Western Mason currently has outstanding bond issues payable to the United States Department of Agriculture Rural Development ("RD") and the Kentucky Infrastructure Authority ("KIA") that were assumed to finance the cost of a water system improvement project. The three-year average principal and interest payments for the years 2015 through 2017 on the water bonds is \$169,254.⁴
- 5. The Commission has historically used a Debt Service Coverage ("DSC") method to calculate the revenue requirements of water districts with long-term debt.

- 6. Application of the Commission's DSC method to Western Mason's proforma operations results in an overall revenue requirement of \$736,516. Revenue of \$710,738 from water service rates is necessary to generate the overall requirement.⁵
- 7. Phase 1 rates calculated by Staff will not produce the revenues necessary to meet the overall revenue requirement of \$736,516; however they will produce revenues sufficient to meet the DSC ratio requirements of Western Mason's lenders.⁶
- 8. The record contains no evidence that permitting Western Mason to assess

 Phase 1 rates will result in any degradation or reduction in the quality of service that

 Western Mason currently provides.
- 9. A utility may assess rates that fail to produce a level of revenues that accepted ratemaking methodologies would regard as insufficient or inadequate. Absent evidence that the quality of the utility's service will decline or be degraded as a result of

this level of revenue, the rate phase-in plan proposed by Staff and agreed to by Western Mason should be accepted.⁷

- 10. Phase 2 rates calculated by Staff will produce revenues sufficient to recover the revenue requirement of \$736,516 as determined by Staff.
- 11. Staff's phase-in plan evenly distributes the revenue increase to all Western Mason's customers. An even distribution of the revenue increase to existing rates results in an equitable spread of the revenue increase to Western Mason's customers and is appropriate, absent any evidence to the contrary.
- 12. The water service rates requested by Western Mason will produce \$726,495 in annual water sales revenues and should be denied.8
- 13. During the test year, Western Mason used service lives for Transmission and Distribution Mains, Meters and Meter Installations, New Meters, Transportation Equipment, and Communication Equipment that are at variance with those found in a survey of the National Association of Regulatory Utility Commissioners ("NARUC Survey") that contain "a range of average service lives currently being used by water

utilities throughout the country for water facilities designed and installed and maintained in accordance with good water works practice."9

- 14. The Commission has previously used the NARUC Survey to establish the services lives of water assets when there is no evidence in the record that supports alternative lives.¹⁰
- 15. The record contains no evidence that the service lives that Western Mason uses for Transmission and Distribution Mains, Meters and Meter Installations, New Meters, Transportation Equipment, and Communication Equipment should be at variance with the NARUC Survey.
- 16. Western Mason's assignment of service lives for these asset groups is not reasonable and should be revised to conform to the NARUC Survey for ratemaking and accounting purposes in all future reporting periods.
- 17. In the near future, the Commission will initiate a new proceeding to more thoroughly investigate Western Mason for issuing indebtedness without prior Commission approval.

IT IS THEREFORE ORDERED that:

- The water service rates requested by Western Mason are denied.
- 2. The water service rates set forth in Appendix A to this Order are approved for services rendered by Western Mason on and after the date of this Order.

3. The water service rates set forth in Appendix B to this Order are approved for services rendered by Western Mason on and after the date of the first anniversary of this Order.

4. No earlier than 30 days, but no later than 20 days prior to implementation of the rates set forth in Appendix B, Western Mason shall publish notice of the Phase 2 rates at least once in a newspaper of general circulation in its territory or place an insert in bills rendered to its customers. Notice shall be in the form set forth in Appendix D to this Order. Western Mason shall file with the Commission proof of publication no later than ten days after publication of the notice.

5. Within 20 days of the date of this Order, Western Mason shall file revised tariff sheets with the Commission, using the Commission's electronic Tariff Filing System, containing the rates set forth in the Appendix A and B to this Order.

6. In all future reporting periods, Western Mason shall use the "PSC Approved Service Life" set forth in Appendix C to this Order for the listed asset groups when calculating and reporting depreciation for all reporting periods after the date of this Order. No retroactive adjustment to accumulated depreciation or retained earnings to account for this change in accounting estimate shall be made.
