### ORDER

On December 4, 2014, Simpson County Water District ("Simpson County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Simpson County purchases water from the White House Utility District ("White House"), White House, Tennessee.
- 2. White House notified Simpson County that effective January 1, 2015, White House would increase its wholesale rate to Simpson County from \$2.4960 per 1,000 gallons to \$2.5541 per 1,000 gallons. Simpson County proposed to increase the water rates to reflect the increased cost of purchased water effective January 1, 2015.
- Simpson County proposed a purchased water adjustment factor of \$.07
   per 1,000 gallons.
- 4. During the 12 months ended September 30, 2014, Simpson County purchased 385,797,140 gallons of water from White House and sold 328,829,520

gallons. The increase in the cost of purchased water is \$22,414.81, resulting in a purchased water adjustment of \$0.07 per 1,000 gallons.

- 5. The purchased water adjustment of \$0.07 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. Simpson County's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after January 1, 2015.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$0.07 per 1,000 gallons is approved.
- The rates as set forth in Appendix B to this Order are approved for water service rendered on and after January 1, 2015.
- 3. Within 20 days of the date of this Order, Simpson County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
