ORDER

On December 29, 2009, in Case No. 2009-00202,<sup>1</sup> the Commission approved rates for Duke Energy Kentucky, Inc. (“Duke”) and provided for their further adjustment in accordance with Duke’s Gas Cost Adjustment (“GCA”) clause.

On January 10, 2014, Duke filed its GCA to be effective January 31, 2014.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Duke’s notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Duke’s Expected Gas Cost (“EGC”) is \$5.070 per Mcf, which is an increase of \$.044 per Mcf from its previous EGC of \$5.026 per Mcf.
3. Duke’s notice sets out its current quarter Refund Adjustment (“RA”) of \$.000 per Mcf. Duke’s total RA is \$.000 per Mcf, which represents no change from its previous total RA.
4. Duke’s notice sets out its current quarter Actual Adjustment (“AA”) of \$.100 per Mcf. Duke’s total AA is \$.103 per Mcf, which represents no change from its

previous total AA.

5. Duke's notice sets out its current quarter Balancing Adjustment ("BA") of (\$.008) per Mcf. Duke's total BA of \$.015 per Mcf represents no change from its previous total BA.

6. Duke's Gas Cost Recovery ("GCR") rate is \$5.188 per Mcf, which is an increase of \$.044 per Mcf from its previous GCR of \$5.144 per Mcf.

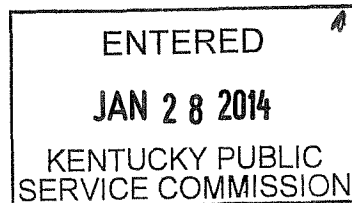
7. The rates as proposed by Duke and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Duke on and after January 31, 2014.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Duke and set forth in the Appendix to this Order are approved for final meter readings on and after January 31, 2014.

2. Within 20 days of the date of this Order, Duke shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
