MOTION TO SCHEDULE AN INFORMAL CONFERENCE


Comes now Jackson Energy Cooperative Corporation (“Jackson Energy”), by and through the undersigned counsel, and hereby moves the Kentucky Public Service Commission for an Order scheduling an Informal Conference in this matter. In support of this motion, Jackson Energy states that it believes an Informal Conference would be beneficial to all parties, and would allow for a discussion of any and all issues pertaining to this case.

Jackson Energy notes that East Kentucky Power Cooperative, its wholesale power supplier, in Case No. 2014-00034, also seeks approval of an economic development rider. Contemporaneous with the filing of this motion, East Kentucky Power is also filing a motion for an Informal Conference in Case No. 2014-00034. Jackson Energy hereby requests that a joint Informal Conference be held with both Jackson Energy and East Kentucky Power attending to answer questions and discuss the two cases which are separate, yet related by similar issues. Jackson Energy believes this will allow for all issues pertaining to the application for the Economic Development Rider to be discussed at once.

Jackson Energy further requests that the Informal Conference be scheduled prior to May 5, 2014.

Wherefore, Jackson Energy respectfully requests that the Commission enter an Order scheduling this matter for an Informal Conference.
