INTRA-AGENCY MEMORANDUM

RE: Telephonic Informal Conference of December 5, 2014

Pursuant to Commission Staff's December 2, 2014 Notice, a telephonic informal conference was held in this matter on December 5, 2014. A list of attendees is attached.

Beginning the conference, counsel for East Kentucky Power Cooperative, Inc. ("EKPC") stated that Mr. Isaac Scott with EKPC and Ms. Michelle Herman with South Kentucky Rural Elective Cooperative Corporation ("SKRECC") would testify at the upcoming December 16, 2014 hearing. Mr. Samford further indicated that Mr. Bill Prather with Farmers Rural Electric Cooperative Corporation ("Farmers RECC"), Mr. Mark Stallons with Owen Electric Cooperative, Inc. ("Owen") as well as Ms. Debbie Martin with Shelby Energy Cooperative ("Shelby") will be available to testify if so desired by the Commission. Mr. Samford stated that if called Mr. Prather and Mr. Stallons will testify to the swings experienced with the environmental surcharge mechanism and the management challenges such swings create. Ms. Martin will testify regarding procedural issues with Shelby's billing and vendor cycles. Mr. Beyer with Commission staff stated that by December 15, 2014 he will inform the parties whether the testimony of Mr. Prather, Mr. Stallons and Ms. Martin is necessary.

Next, Commission staffer Mr. Handziak requested Farmers, Shelby and SKRECC provide revisions and updates to their responses to Staff's Fourth Request for Information. The parties agreed to provide the information by Friday, December 12, 2014.

Finally, the parties questioned whether each utility should file a copy of the public hearing notice in addition to the affidavit. Staff indicated that because a single joint notice in the Kentucky Living publication was utilized, submission of the affidavits would be sufficient.

Finding that no party had any further questions, the conference was adjourned.
