

COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION  
TO GRAYSON RURAL ELECTRIC COOPERATIVE CORPORATION

1. Refer to Grayson's response to Item 2.b. of Commission Staff's Initial Request for Information. The response states that 94 customers are currently taking service under Schedule 3.
  - a. Identify the customer classes to which the 94 customers will be transferred if Grayson's request to make Schedule 3 a rider is approved. Include in the response the number of customers that will be transferred to each customer class in such case.

Response:

Currently there are 93 customers taking service under Schedule 3.  
Two (2) will be transferred to the Small Commercial Schedule 2.  
Two (2) will be transferred to the General Schedule 17.

- b. For each customer that would be transferred to a class other than the Farm and Home class, state the class to which the customer would be transferred and provide the 2013 billing determinants for each of those customers.
