**APPLICATION FOR
CERTIFICATE OF CONVENIENCE AND NECESSITY**

The Petitioner of Todd County Water District specifically shows:

(a) Applicant is engaged in the business of selling portable water in the unincorporated areas of Todd County and a portion of Logan County, Kentucky.

(b) The Post Office address of the Applicant is P.O. Box 520, Elkton, Kentucky 42220.

(c) The Todd County Water District has for many years rented an office building from the City of Elkton, Kentucky for its administrative offices and has been without a maintenance facility for its operations. The Commissioners of the District propose to construct an approximately 2,500 square feet building and a maintenance facility adjacent thereto on a tract of real estate owned by the District to provide administrative office space and maintenance/warehouse space for the operation of the District. The Applicant will utilize existing funds for the construction of the project. Applicant estimates the cost of the project at \$800,000.00. Applicant currently has available \$1,856,886.00 in existing funds from which to pay for the project. Applicant proposes to pay for the project from existing funds.

WHEREFORE, Applicant asks the Public Service Commission of the Commonwealth of Kentucky make its order authorizing Applicant to construct an office and warehouse facility.
