17	ten redacted hard copies of material containing confidential information submitted pursuant to a	
18	petition for confidential treatment.	
19	Big Rivers is filing with this motion its responses to the Initial Requests for Information	
20	of the Office of the Attorney General ("AG") and Kentucky Industrial Utility Customers, Inc.	
21	("KIUC"). Big Rivers has produced the attachments to Item 12 of the AG's Initial Request for	
22	Information and Items 4, 7, 8, and 10 of KIUC's Initial Request for Information in electronic	
23	format on the CONFIDENTIAL electronic media filed with this motion. These files have been	
24	produced electronically for one or more of three reasons: (i) if printed, the files would be	
25	approximately one hundred (100) pages or more and would overburden the paper record in this	
26	matter; (ii) the files are designed for electronic viewing or contain information, such as formulas	
27	only viewable in electronic format; and/or (iii) the files were requested electronically in the	
28	corresponding data request.	
29	Additionally, the pervasive nature of the confidential information makes the production	
30	of ten redacted, public versions of these documents ineffectual and unhelpful to the Commission	

	the parties, and the public. Big Rivers has not produced a redacted, public version of these	
2	documents that have been produced confidentially in electronic format.	
3	WHEREFORE, Big Rivers respectfully requests that the Commission enter an order	
4	granting Big Rivers deviation from 807 KAR 5:001 Section 13 to: (i) produce the attachments in	
5	electronic format; and (ii) omit PUBLIC, redacted copies of the CONFIDENTIAL attachments.
