Dear Mr. Derouen:

On December 17, 2014, the Kentucky Public Service Commission issued an order in the above-referenced matter granting Big Rivers Electric Corporation's motion for rehearing of the Commission's November 21, 2014, order. The November 21 order granted in part and denied in part Big Rivers' request for confidential treatment of portions of an ACES study. Ordering paragraph number four of the December 17 order directed Big Rivers to re-file the ACES study to reflect the redaction of information granted confidential treatment in the November 21 and December 17 orders.

When Big Rivers filed its motion for re-hearing on December 1, 2014, it included revised confidential and public versions of the ACES study. The revised confidential version reflects as confidential the information granted confidential treatment in the November 21 and December 17 orders, and the revised public version reflects as redacted the information granted confidential treatment in the November 21 and December 17 orders. For that reason, Big Rivers respectfully requests that the Commission accept that filing as compliance with ordering paragraph number four of the December 17 order.
