A public meeting in Case 2014-00136 was conducted at 6:30 p.m. on Tuesday, September 16, in the parking lot of the Lovelaceville United Methodist Church in Lovelaceville. (The caretaker of the church did not appear as scheduled to unlock the building.)

An attendance sheet is attached. Several people attended but did not sign in. Total attendance was about 15 people.

Andrew Melnykovych of the PSC staff opened the meeting by providing an update on the case and explaining the procedure for the hearing on September 17. He noted that no entity had come forward to express an interest in acquiring or operating the system. Customers in attendance asked a number of questions focused largely on the timing of any abandonment, the options available to customers and the possibility of financial assistance in the event that it becomes necessary for customers to drill wells or install cisterns.

Customers were encouraged to contact the PSC to express their views on an appropriate time frame for any abandonment and transition. They were referred to the local health department and area development district for information on possible sources of financial assistance.

The meeting ended at about 7:15 p.m.

On September 17, 2014, a video conference call was arranged to enable the submission of public comments during the scheduled formal hearing. An attendance sheet is attached.
