the time period 11/5/13-3/7/14

c. provide the current location of unit 90537102

d. provide explanation regarding why the unit was not returned to our property after it was deemed to be working properly

e. provide explanation of process for reading the meter to determine the usage. Was the same process and equipment used each time? Provide details

regarding the specific equipment used to read the meter each time

f. provide names or employee no. for all employees that read and reread the meter on our property between 11/5/13-1/7/14 and how long those

employees have been employed by KAWC

g. provide a list of all complaints or "rereads" related to the Neptune 5/8 x 3/4 cubic

feet meters,

h. provide a list of all complaints or "rereads" related to the employees that read and/or reread our meter from 11/5/13-1/7/14

i. provide specific information regarding what type of meter is currently in place on our

property

j. provide information regarding the age of the meter with serial no. 90537102 and the average "life span" for these meters
