- 6. Provide non-identifying employee no. for all employees that read and reread the meter on our property between 11/5/13-1/7/14 and how long those employees have been employed by KAWC in that specific capacity.
- 7. Provide a list of all complaints or "rereads" related to the Neptune 5/8 x 3/4 cubic feet meters.
- 8. What is the malfunction history or malfunction percentage ratio of the Neptune 5/8 x % cubic feet meter?
- 9. Provide a list of all complaints or "rereads" related to the employees that read and/or reread our meter from 11/5/13-1/7/14.
- 10. Provide specific information regarding what type of meter is currently in place on our property located at 3649 Winding Wood Lane, Lexington, KY.

- 11. Provide information regarding the age of the meter with serial # and the average "life span" for Neptune 5/8 x 3/4 meters.
- 12. Provide explanation of how and why a Neptune 5/8 x 3/4 typically malfunctions.
- 13. Provide an explanation of other instances where KAWC has seen usage of 250,000 gallons of water consumed in 63 days. Has this ever been recorded in a household containing 2 people?
