On October 24, 2014, SunCoke Energy South Shore LLC ("SunCoke") filed an application for Siting Board approval of: (1) the construction of a merchant electric cogeneration coking facility in South Shore, Kentucky; and (2) a 0.7-mile, 138-kilovolt, non-regulated radial tie line to convey electric power produced by the facility to American Electric Power's Milbrook Park substation in New Boston, Ohio.
