## MOTION TO CANCEL FORMAL EVIDENTIARY HEARING OR, IN THE ALTERNATIVE, TO EXTEND THE DATE TO FILE DIRECT TESTIMONY

- 1. That the Scheduling Order herein has set Formal Evidentiary Hearing for January 28, 2015 and the deadline to file direct testimony is scheduled for January 5, 2015.
- 2. That the Application herein was duly filed and determined to be administratively complete and that the Applicant herein has received and responded to the best of its ability to each of the data requests served upon it.
- 3. That no third party has filed a request for a local public hearing nor for a formal evidentiary hearing in this proceeding.

- 5. That the Applicant has not been advised by the board or any of its staff members that there are any outstanding issues which need to be the subject of an evidentiary hearing.

Based on the foregoing, the Applicant moves the board for an order cancelling the formal evidentiary hearing currently scheduled in this matter and the procedural steps

leading up to such hearing, including but not limited to, the requirement to file direct testimony on or before January 5, 2015. In the alternative, the Applicant moves the board for an order extending the date to file any direct evidentiary testimony or evidence from January 5, 2013 to and including the close of business on January 9, 2015. In further support of this request for an extension, counsel states that in addition to the intervening holidays, which have made it extremely difficult to obtain necessary information, counsel for the Applicant has been out ill for the last ten days and has been unable to direct the preparation of any necessary evidentiary material or testimony.

WHEREFORE, the Applicant moves that the evidentiary hearing currently scheduled in this matter for January 28, 2015 be cancelled by the board or, in the alternative, that the board grant the Applicant until and including the close of business January 9, 2015 to file any direct testimony or other direct evidence which may be required prior to the evidentiary hearing herein.
