
Now come City of Hillview, Kentucky (Hillview) and City of Hunters Hollow, Kentucky (Hunters Hollow) and move that they be granted full intervention herein. In support of this motion, Hillview and Hunters Hollow state as follows:

1. City of Hillview, Ky's address is 283 Crestwood Lane, Louisville, Bullitt County, Kentucky 40229, email address kgathof@hillviewky.org.
2. City of Hunters Hollow, Ky's address is 11300 Angelina Road, Louisville, Bullitt County, Kentucky 40229, no email address.
3. Hillview and Hunters Hollow are municipal corporations of the Commonwealth of Kentucky and between the two cities include the entire service area of Bullitt Utilities, Inc. All current users of this sanitary sewer provider are residents of these two cities with approximately 700 users being located in Hillview and 200 users being located in Hunters Hollow. The outcome of this case will affect the individual citizens and businesses located within the respective municipal boundaries and will have a direct economic impact on the ability of the respective City to insure sanitary sewer service at a reasonable rate to its current and future residents.

4. Hillview and Hunters Hollow should be permitted to intervene because their interest are not otherwise adequately represented by any other party. Further their intervention will likely present issues or develop facts that assist the Commission in full consideration of the matter without unduly complicating or disrupting the proceedings and without prejudice to any other party.

WHEREFORE, Hillview and Hunters Hollow move to be granted full intervention and that they be afforded any and all relief to which they may appear entitled.


