### ANSWERS OF BULLITT UTILITIES, INC., TO COMMISSION STAFF'S FIRST INFORMATION REQUESTS

Comes Bullitt Utilities, Inc. ("Bullitt Utilities"), and for its Answers to Commission Staff's First Information Requests, provides the following information. This information is in addition to the information previously provided in response to the requests for information set forth in the Commission's Order of May 22, 2014, and the Post-Hearing Data requests:

Information Request No. 1: Provide the following information for the project authorized in Case No. 2014-00255.

Information Request No. 1a: Provide a copy of the Kentucky Division of Water ("KY DOW") approval letter for the construction permit to construct the project for transmitting wastewater from the Hunters Hollow collection system to BCSD.

Answer: See Attachment 1, which was attached to the Answers of Bullitt Utilities, Inc., to Post-Hearing Data Requests which were filed with the Public Service Commission ("Commission") on June 23, 2015, in Case No. 2014-00255.

Information Request No. 1b: Provide a copy of the signed contract between Bullitt Utilities and Clark providing for the construction of the project, the Notice to Proceed, and a copy of the down-payment check. If the contractor is not Clark, identify the contractor and provide the same information. If no construction contract has been executed, explain why, and state Bullitt

Utilities' plan to procure a contractor for the project.

**Answer:** See the signed contract between Bullitt Utilities and Larry Clark Construction, Inc., attached hereto as Attachment 2.

**Information Request No. 1c:** Provide a copy of each payment request from Clark or the contractor. For each payment request, state whether the request has been paid and provide supporting documentation to verify payment.

Answer: No payment requests have been submitted by Larry Clark Construction, Inc., as it has done very little work on the project. Bullitt Utilities is unable to obtain the financing needed to pay the substantial cost to construct the pump station and wet well, which cost is approximately Three Hundred Fifty Thousand Dollars (\$350,000.00). Additionally, the monthly revenue received by Bullitt Utilities from its customers is insufficient to pay the monthly expenses incurred by Bullitt Utilities in operating and maintaining the Hunters Hollow collection system and no funds are available to pay for the connection of the pump station and wet well. Bullitt Utilities' Application for Surcharge filed in Case No. 2014 - 00255, now pending before the Commission, has not yet been ruled upon. Since there are no funds to pay the cost to construct the pump station and wet well, no further work has been undertaken by Larry Clark Construction, Inc. Bullitt Utilities is unable to state at this when the construction of the pump station and wet well will be completed, as approval of the Application for Surcharge is required before any additional work can be performed on the pump station and wet well. The Application for Surcharge was deemed filed by the Commission on December 23, 2014, the formal hearing on the Application for Surcharge was held on Tuesday, June 9, 2015, and Commission has not yet issued its ruling on the Application for Surcharge.

**Information Request No. 1'd:** State whether Bullitt Utilities has commenced construction of the project for which the CPCN was granted.

Answer: See Answer to Information Request No. 1( c).

**Information Request No. 1e:** If Bullitt Utilities has commenced construction, provide a summary of the construction activity to date and identify the remaining construction activity as well as all other steps necessary to complete the project.

Answer: See Answer to Information Request No. 1( c).

Information Request No. 1f: If Bullitt Utilities has not commenced construction, state why it has not.

Answer: See Answer to Information Request No. 1( c).

**Information Request No. 1g:** Provide the anticipated date that the project will be substantially complete. If there is a letter indicating the substantial completion date of the construction, submit the letter with the response.

Answer: See Answer to Information Request No. 1( c).

Information Request No. 1h: If Bullitt Utilities has not obtained all approvals, permits, or other authorizations to complete the project, identify any approvals, permits, or other authorizations that are necessary and state the status with respect to obtaining any such item and the corresponding anticipated date that the approval, permit, or authorization will be obtained. Answer: As is reflected in Attachment 1, Bullitt Utilities has obtained the necessary authorization from the Kentucky Division of Water authorizing the construction of the pump station and wet well. Approval of the Application for Surcharge is required before any additional work can be performed on the pump station and wet well. See also Answer to Information Request No. 1( c).

**Information Request No. 1i:** Provide any reports from any resident inspector that is employed by Bullitt Utilities, BCSD, or any consultant of the aforementioned.

**Answer:** Bullitt Utilities objects to this Information Request on the basis that it is vague and ambiguous and incapable of answer without speculation as to its meaning. However, without waiving this objection, see Answer to Information Request No. 1( c).

**Information Request No. 2:** Refer to the Answer of Bullitt Utilities to the Commission's Order of May 7, 2015, in this proceeding . Provide the following information.

**Information Request No. 2a:** State whether Bullitt Utilities has completed the work to connect the Hunters Hollow collection system with the BCSD sanitary sewer system. If so, provide the date that the work was completed. If not, state why not and provide the anticipated date that the work will be completed.

Answer: The work to connect the Hunters Hollow collection system to the Bullitt County Sanitation System ("BCSD") was completed on May 27, 2015.

**Information Request No. 2b:** State whether Bullitt Utilities is transmitting wastewater from the Hunters Hollow collection system to BCSD. If so, provide the date that the transmission began. If not, state why and provide the anticipated date that the transmission will begin.

Answer: Bullitt Utilities began pumping wastewater to BCSD on May 27, 2015.

**Information Request No. 2c:** State whether Bullitt Utilities has had any bypass events for wastewater collected for the Hunters Hollow collection system since May 21, 2015. Provide any documents supplied to the KY DOW regarding each bypass event since May 21, 2015.

Answer: The Bypass Reports filed with the Kentucky DOW for bypass events occurring since

May 21, 2015, are attached as Attachment 5.

**Information Request No. 3:** Provide any correspondence and documentation exchanged between Bullitt Utilities and KY DOW since May 21, 2015.

Answer: See Attachments 3 and 4.

**Information Request No. 4:** Provide any correspondence and documentation exchanged between Bullitt Utilities and BCSD since May 21, 2015.

Answer: See Attachment 5.

**Information Request No. 5:** Provide all documentation, including any log books containing daily activity, that identifies the volume of wastewater transmitted from the Hunters Hollow collection system to BCSD since May 21, 2015.

**Answer:** Bullitt Utilities's log books do not identify the volume of wastewater transmitted from the Hunters Hollow collection system to BCSD during the relevant time period. The log books specify the pumping rate at the time the pumps are checked.

**Information Request No. 6:** Provide a schedule of all costs incurred since May 21, 2015, to any vendor, government agency, or third party in response to any bypass event since May 21, 2015, including but not limited to costs to clean a receiving stream and costs to remove or contain wastewater that has left the Hunters Hollow collection system consequent to a bypass event. For each cost, state whether the cost has been paid. If it has been paid, provide the date of payment and source of funds for the payment.

Answer: See Attachment 7.





## FIRST ADDENDUM TO CONTRACT FOR CONSTRUCTION HUNTERS HOLLOW PUMP STATION (Dated May 22, 2015)

1. The paragraph titled "Payments To Contractor, Initial Payment is revised to delete the sentence stating "Initial payment of 25% of the contract price will be made by the Owner to the Contractor are monies advanced for the purpose of assisting the Contractor to expedite the work of construction." This deleted sentence is hereby replaced with the following sentence, "The Owner shall make an initial payment of \$1,000 to the Contractor, and thereafter the Contractor will issue its invoices by the end of the month for work performed during that month, and the Owner will issue payment on the immediately preceding invoice on or about the fifteenth day of the next month." The remaining provisions of the paragraph titled "Payments To Contractor, Initial Payment" shall remain in full force and effect.

2 The paragraph titled "Disputes" is revised to add the following provisions as paragraph 3 d., "Mediation. Claims, disputes or other matters in question between the parties to this contract shall be first subject to pre-suit mediation prior to the filing of any legal claims or litigation. Pre-suit mediation is a condition precedent to litigation. The obligation to mediate is a material and essential provision of this Contract. Unless otherwise agreed in writing, the CONTRACTOR shall carry on the performance during any mediation or litigation. Either party may initiate a mediation proceeding by submitting a request in writing to the other party within a reasonable time after the claim, dispute or other matter in question has arisen, but in no event after the applicable statute of limitations has expired. The parties shall endeavor in good faith to mutually agree upon an acceptable mediator. In the event the parties have not agreed upon a mediator within 30 days of the request for mediation, the OWNER shall select a mediator. Each party is to bear its own fees, costs and expenses of said mediation. In the event that mediation is unsuccessful, all claims, disputes or other matters in question shall be resolved in the Circuit or District Courts of Bullitt County, Kentucky."



#### Hunters Hollow Subdivision SSES Comments:

- 1. The SSES was not complete. A number of tasks needed in the SSES are listed as yet to do in the CAP.
- 2. The Division of Water (DOW) does not understand why activities such as smoke testing lines looking for illegal connection are considered beyond the scope of the study. It is the opinion of DOW that illegal connections and leaks are a major source of inflow into this system and should be a focus of the study. Part of the system was not even considered.
- 3. The submitted document called a CAP is not a Corrective Action Plan. A CAP should list the problems encountered while completing the SSES and then discuss and prioritize the problem areas needing work and perhaps giving reasons for their selection.
- 4. The CAP would also provide a schedule for doing the needed remedial work.
- 5. There should also be a provision for yearly (if not more frequent) reports on the success of the work as it is completed.
- 6. In short, the documents should tell us what they did to study the situation, what was found, what is needed to fix things and how and when they propose to do the work.

As we discussed during our telephone conversation on July 13, 2015, Linda Wood is forwarding to you on this date a check in the amount of 2,041.71 made payable to Bullitt County Sanitation District ("BCSD") in payment of the sanitary sewer services provided by BCSD to Bullitt Utilities during the month of May, 2015. The information provided to Ms. Wood by the Louisville Water Company reflects that Bullitt Utilities' total receipts for May of 2015 were 15,823.22. (See Attachment A: Blue Lick - 4,872.87, Hunters Hollow - 10,950.35) This equates to receipts of 510.426 per day. (15,823.22 divided by 31) BCSD began accepting Bullitt Utilities' wastewater on May 27, 2015, and it is to be paid for treatment of wastewater from May 27 through May 31, 2015. The following calculations reflect that BCSD should be paid the amount of 2041.71 for May of 2015. (510.426 times 5 = 2,552.13 times .80 = 2041.71)

The Louisville Water Company has been requested to make the payment directly to BCSD, but has advised Ms. Wood that it will not do so.
