We are already paying enough for no more than we are getting from AIRVIEW UTILITIES LLC.

There are sewage problems, and we get absolutely NO help from these people when we call. Usually we get an answering machine, in which you leave a message and it goes unanswered. Almost every time it rains 98 % of the residents with basements must cali in a plumber, because of the sewage backing up in their basements, back yards and bathroom tubs. One family almost lost their child due to the drain in their bathroom not draining properly, (the child had a near drowning experience and had to be in the ICU at Kosair's Children's Hospital in Louisville KY. (117 Hickory Hill Drive)).

At the present time these people are just taking our money and we are getting nothing in return, as far as help with these above problems. Very seldom do we see a chemical truck or anyone else going to the sewage area. So where is our \$28.45 a month per resident going???

Most of the residents are on a fixed income and can't afford this Kind of rate hike. As it is now we are paying too much for no more than what we are getting as a service from Airview Utilities LLC. They could care less about the problems, they don't live out here and they don't have to deal with these issues.

Airview Utilities stated, "That they would provide adequate sewer service." Where is the adequate service????

So as residents we feel that we have a right to make you all in Frankfort aware that there are issues and we are not receiving any help from these people at AIRVIEW UTILITIES LLC. We are opposing a rate hike that will put a financial burden on each resident.

On June 30, 2014 Airview Utilities, LLC has filed an application with the Public Service CoDMMSGORION proposing to increase its monthly sewer rate from \$28.45 to \$42.00, an increase of 47.6%. Airview Utilities, LLC believes it could justify an even greater increase, but is proposing the increase to \$42.00 to reduce the burden upon its customers. The proposed increase is necessary to provide adequate sewer service and to fully comply with existing and new environmental requirements. The proposed effective date of the change is July 30, 2014.

If the PSC does not receive a written request for intervention within 30 days of the mailing of this notice, the PSC may take final action on the application. A motion to intervene shall be in writing, shall be submitted to the Executive Director, <u>Public</u> Service Commission, 211 Sower Boulevard, <u>Post Office Box 615</u>, <u>Frankfort, KY 40602</u>, and shall set forth the grounds for the motion, including the status and interest of the party movant. Copies of the application may be examined or obtained at no charge from the utility office at Airview Utilities, LLC, P.O. Box 91588, Louisville, KY 40291. Also, the application and all documents filed with the Public Service Commission may be viewed and downloaded at the Public Service Commission's website at <u>http://psc.ky.gov</u> or viewed at the PSC's office at 211 Sower Bivd. Frankfort KY from Monday-Friday 8am - 4.30 pm. Comments regarding the application may be submitted to the PSC through the PSC's website or via mail at Public Service Commission, P.O.
