On August 15, 2014, the Commission held an informal conference in this case in the Commission's offices in Frankfort, Kentucky. Present were those persons whose names appear on the attached sign-in sheet, attached hereto and incorporated herein as "Exhibit A". Amerigas Partners, LP ("Amerigas") and Commercial Propane Service LLC ("CPS"), hereinafter ("Joint Applicants") requested the conference.

Staff and the Joint Applicants discussed several issues pertaining to CPS's proposed acquisition of Amerigas's utility assets in Old Bridge Subdivision, Danville, Kentucky. Counsel for Joint Applicants distributed a five-page exhibit, a copy of which is attached hereto and incorporated herein as "Exhibit B," which was reviewed and discussed by the Joint Applicants and Staff. In addition, Staff questioned the status of Amerigas's 2013 Annual Report, which has not yet been filed with the Commission. Counsel for the Joint Applicants stated that the Annual Report was being prepared and would be filed in the near future. Staff indicated that the filing of this report was necessary to its review of the pending application. In response to questions from Staff, it was represented that each customer of the Old Bridge utility was notified via letter of the proposed transfer of the utility assets from Amerigas to CPS.

Other issues discussed were the number of customers; the applicability of the current five year Distribution Integrity Management Plan, possible modification of how the gas cost adjustment is calculated; CPS's plan to retain the same accounting firm that has worked with the utility since its inception, due to its familiarity with what is required for the Annual Report; and whether there are any tax implications regarding the date of transfer. Joint Applicants stated that they would like the transfer to be completed prior to the 2014-15 heating season.

The conference then adjourned.




