The proposed monthly water rates shall be effective for water sold after the date of the final approving Order of the PSC, which Order is expected to be issued with 30 days of the filing of the Application.

The amount of everage usage for all customers in the calendar year 2013 was 3,043 gallore per month thus generating an everage monthly billing besed on current rates of \$31.44. The proposed monthly rates will increase the everage monthly billing to \$32.48 for an impact of \$1.05 or 3,35%.

The Application for approval of the rate change has been filed with the PSC and may be examined during normal business hours at the following localitons: (i) Barkilly Lake Water Garter sities, 1420 Canton Raad, Cadd, Nentucky, (ii) PSC, 211 Sower Boulevard, Frankfort, Kartucky, Monday brough Fraids, 260 a.m. b. 20 pm. E.T. and (iii) with the PSC webset of this place ky gov. Comments regarding the Application may be submitted to the PSC via its webelse or by mail to PSC, P.O. Box 815, Frankfort, Kanticcy 40602.

The RO lean proceeds will be used in conjunction with a \$275,000 RO grant to finence the cost of the construction and/or installation of (i) a 300,000 gallon water storage tank; (ii) a booster pump station; and (iii), 8 inch water transmission mains and appurtenances.
