As indicated in my letter to you of August 20, 2014, Bullitt Utilities, Inc., has been in discussions with the Kentucky Division of Water, the Bullitt County Sanitation District ("BCSD") and the Louisville and Jefferson Metropolitan Sewer District concerning various options to respond to the failure of the Hunters Hollow Wastewater Treatment Plant, which is the subject of the above referenced Application. As recently as September 20, 2014, Bullitt Utilities forwarded a revised offer to BCSD, but has not yet received a response to this offer. Since the resolution of these discussions, as well as the September 20, 2014 offer, could have a significant impact on the Application and any amendments that may need to be made to same, I am hereby requesting that Bullitt Utilities be provided with an extension of time until October 3, 2014, to respond to your request.
