


MEMORANDUM IN SUPPORT

Pursuant to 807 KAR 5:001, Section 5, Total Call Mobile, Inc. ("Total Call") respectfully requests leave to file this motion for extension of time. 807 KAR 5:001, Section 5(1) states that "[a]ll requests for relief that are not required to be made in an application, petition, or written request shall be by motion. A motion shall state precisely the relief requested." Total Call requests an extension until Thursday, December 18, 2014 to file responses to Staff's Initial Request. The justification for this request is provided below.

On September 24, 2014, Commission Staff issued Staff's Initial Request to Total Call. On October 28, 2014, Total Call requested an extension to respond to Items 2, 7, 8, and 9 of Staff's Initial Request. On November 21, 2014, the Commission granted Total Call's request for an extension, and found that Total Call should file responses to the remaining items in Staff's Initial Request by December 4, 2014.

Total Call is diligently working to adequately and thoroughly respond to these remaining items. Total Call, however, was unable to file the requested information by December 4, 2014. Therefore, Total Call respectfully requests leave from the Commission to file this motion for a brief extension of time. Total Call seeks an extension until Thursday, December 18, 2014 to file responses to Items 2, 7, 8, and 9 of Staff's Initial Request. This short extension will not prejudice any party, and will provide Total Call adequate time to gather and file all of the information requested by Staff.
