At this time Springcrest Sewer Co Inc. request a one year delay in the daily inspections of Springcrest Sewer facility. In support of the request the following information is submitted.

1. On Oct. 17, 2014 a telephone conference was conducted by Mr. David Spenard, Staff Attorney for Kentucky Public Service Commission. Several issues were discussed pertaining to the Sewer Facility.
2. At this time it creates a financial hardship to Springcrest Sewer Co. Inc. The funds are not available. The monthly expenses exceed the monthly income. This does not include the electric bill or any additional fuel expenses.
3. With the installation of the emergency pump to the facility there have been no issues.
4. I have researched several auto dialers. This would be the most cost effective solution after the initial cost of the device. The monthly fee ranges

\$28.00 to \$50.00 per month. This is a large savings over the cost of fuel.

5. A loan was obtained to pay for repairs in 2013. The existing loan will be paid off at the end of October 2015. At this time the new equipment could be purchased and installed.

6. When I obtained this facility, I was advised a dailey inspection was mandatory. I agreed to perform daily inspection in 1995 at a rate per month of \$475.00 per month. Case No. 95-289 page 5, Commission found no more than two visits per month were necessary.

7. Base on the information provided, we feel the one year delay is not only necessary but reasonable.

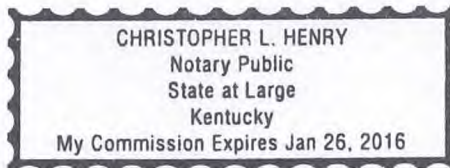
