Joint Application of Kenergy Corp. and Big Rivers Electric Corporation for

Approval of Contracts

Pursuant to a Staff Notice, a telephonic informal conference ("IC") was held on November 6, 2014 at the Commission's offices in Frankfort, Kentucky for the purposes of discussing any issues relating to the application. A list of the attendees is attached hereto.

At the outset of the IC, a discussion was held regarding the request of Big Rivers Electric Corporation ("Big Rivers") and Kenergy Corp. ("Kenergy") (collectively "Joint Applicants") that a decision be rendered in this case on or before November 24, 2014. Joint Applicants initially indicated that December 3, 2014 would be the latest date that an order could be issued on the joint application, but in a follow-up phone call Joint Applicants indicated that an order was needed by December 1, 2014 to allow sufficient time for the filing of an application with the Midcontinent Independent System Operator, Inc. ("MISO") to effectuate the transfer of the market participant by January 1, 2015. Joint Applicants indicated that the next available effective date within MISO's scheduling framework to transfer the market participant would be March 1, 2015.

In response to Commission Staff inquiries, Joint Applicants indicated that the instant application could not have been filed any sooner than October 21, 2014 due to the fact that certain credit issues had to resolved to the satisfaction of all the parties involved. Joint Applicants further indicated that any expenses incurred by Kenergy as a result the change in the market participant would be borne by Century Aluminum Sebree LLC, Century Aluminum of Kentucky General Partnership, or Century Aluminum Company under the appropriate Electric Service Agreement.

There being no further discussions, the IC was adjourned.
