My dear PSC: The so-called fixed rate increase proposed by the utility KU, SHOULD BE a variable fixed rate proportional to the quantity of power consumed.

Discussion: The reason why the utility prefers to request such "across the board fixed rate increases" is because they know that the typical consumer (i.e.,the low-hanging fruit) will not fight it, whereas the large consumers are organized and will go ballistic if they are adversely affected, the big outfits have their hires to create mischief for the utility.
