Pursuant to the Commission's Order of March 6, 2015 an informal conference ("IC") was held in these matters at the Commission's office in Frankfort, Kentucky on April 16, 17, and 20, 2015. At the request of Kentucky Utilities Company and Louisville Gas and Electric Company, the IC was scheduled to allow the parties an opportunity to discuss the issues in these proceedings. A list of attendees for the IC is attached to this memorandum. All parties to the cases participated in the IC with the exception of the United States Department of Defense and all other Federal Executive Agencies, who is an intervenor in Case No. 2014-00372.

The parties negotiated a unanimous settlement agreement which is intended to resolve all issues in the cases. The agreement was filed with the Commission on April 20, 2015 and was subject of a formal hearing by the Commission on April 21, 2015.
